AN EXPLORATORY MARKET ASSESSMENT OF WOOD USE IN JAPANESE RESIDENTIAL FLOORING AND WINDOWS

ABSTRAC

Traditionally, building products for residential construction in Japan have been produced almost exclusively in Japan. Recently, conomic concerns and an increased interest in western style and designs not domestically produced have led to increased imports of western style products by Japan. This paper reports on a study that collected exploratory information on the Japanese market for wood flooring and window products through personal interviews with house builders in Japan. The large Japanese wood flooring market is supplied primarily by domestic production. Results of this study show that Japanese house builders prefer ready-to-install, light-color-matched floors with polyterthane finishes. The best opportunities for those interested in exporting to Japan lies with solid softweet and thardwood flooring and ready-to-install venered softwood flooring. While demographic factors will reduce overall housing starts in Japan, there clearly are opportunities for imported building products in the growing markets for wood flooring and windows.

This paper presents information on Japanese flooring and window markets, with an emphasis on wood use in this context. Literature relating to these products in the Japanese market has tended to focus mainly on domestic prosuppliers, but not product attributes and service issues (13,18). This study investigated the product attributes of flooring and windows desired by Japanese buyers and the potential for foreign producers wishing to export to Japan to increase wood products sales in this sector.
